### **UNDERSTANDING PAST TRUTHS**

In 2020, Family Promise nationwide affiliates formed the Racial Justice Council to ensure we collectively address racial equity issues at all levels within the work we do as individual agencies. Marissa Commey stepped up and is committed to being a leading member in policy, practices, and procedural changes to aid in the principles of Diversity, Equity, Inclusion, and Access (DEIA). The council was created to address the systemic and structural racism that disproportionately causes Black, Brown, and Indigenous people to be affected by homelessness and poverty.

This past June, Marissa returned to her home state of Oklahoma to honor the centennial anniversary of the historic 1921 Tulsa Race Massacre.

This event was an 18-hour attack on the thriving segregated neighborhood of Greenwood.

According to the commission's 2001 report, 100 to 300 people were killed, and more than 8,000 people became homeless. Later there was an attempt to restore the district, but efforts were disrupted after planners decided to build a highway through the area. This event is one of many examples of systemic and structural racism.

Rooted in understanding significant truths of the past, Marissa brings a perspective of compassion and empathy to her work as the Manager of Community Engagement. She incorporates the DEIA concepts daily and provides

training to our staff to advance our genuinely diverse and anti racist agency.

### TO HELP SOMEONE IS TO EMPOWER THEM

"What I do is very rewarding and meaningful", says Melissa Wong, Senior Staff Attorney in the **Public Benefits** department at Legal Aid Society of

Hawaii.

Straight out of Law School, Hawaii-born Melissa joined Legal Aid not knowing she would love working for a non-profit organization. It has been five years; her passion to help has not wavered.

Melissa is also staunch advocate for education, constantly encouraging her clients to be pro-active. "I try to empower them that they could make a difference especially if they experienced injustice. They have a powerful voice. Melissa and the Legal Aid's

Other benefits that Legal Aid assists with are TANF/TAONF (cash assistance), SNAP, and Med-QUEST (for state), and SSDI and SSI for disabled adults and SSI for disabled children (for federal).

As a young child, Julianne saw her mother struggle with being unable to read and write in both her native language and with English. She was inspired by her mother's strength to seek out help to not only read and write in her second language but also to improve her life. # FOCUS ON: ASSOCIATION OF LEGAL ADMINISTRATORS

The Association of Legal Administrators (ALA) Hawaii Chapter was established in 1974 to enhance and promote the quality of management in legal service organizations in Hawaii. The Chapter's over 34 members represent 25 local law firms.

Each year the Association of Legal Administrators (ALA) Hawaii Chapter selects a non-profit organization to support in its community connection event.

This year, ALA decided to support the Kids Hurt Too Hawaii agency under the umbrella of Kukui Center which is a nonprofit which works with grieving children and their families. Cynthia White, its Executive Director, mentioned that they need a chair rack to safely stack chairs in their agency so that no children will get hurt while playing near the chairs. The agency could not find a suitable one on island or online and the shipping costs were prohibitive. Lymari Graciano, Administrator for AM Pacific Group LLP, who also has a background in filmmaking in which she has experience in designing and ordering specific custom-built apparatuses, knew exactly who to call and selected two builders to create/customize a chair rack/mover specific for Kids Hurt Too Hawaii. One of the builders is a retired grade school teacher and his input was invaluable. The chair rack was designed so that the children would not potentially hurt themselves; i.e. no sharp edges, no protruding screws/nails, nothing that could smash fingers, no ability to lock someone inside, no ability to climb on top of the rack. The original design was adjusted from building one giant chair rack into building two smaller chair racks for maneuverability and weight so **the** children could actually push and stack the chairs. As an extra feature, the chair racks were painted with chalkboard paint on the sides, so the kids can draw on it or the adults can write instructions on it.

For this year's Community Challenge, the local Hawaii Chapter raised over \$2720.00 from its generous-members and business partners! All excess money raised was used to purchase school supplies to fill 100 school backpacks.
